Per TCA §2-3-109(e)(1) and (2) Disabled and elderly voters in inaccessible precincts have the right to come to the County Election Commission Office to vote, either during the period established for early voting or on election day. Please be advised that any disabled voter who will be voting for the first time pursuant to this provision must provide the commission with written notice by July 25, 2016 of his/her intention to vote at the commission office on election day.

Anyone wishing to request an Absentee Ballot by Mail may do so by contacting this office. The last day that this office can receive and/or process a request for an absentee ballot by mail for the State Primary and County General Election is July 28, 2016.
